1. Call to Order

L. Cohen called the meeting to order at 7:00 pm.

2. Citizens’ Time

Jack Fernandez explained his plan to clean up Little Brook with 40 volunteers. This would occur Saturday November 3 from 9am to 11am. Conservation Commission supported the plan.

3. Approval of Minutes – October 11, 2018

A MOTION TO APPROVE THE MINUTES FROM THE OCTOBER 11, 2018 CONSERVATION COMMISSION MEETING WAS MADE BY E. LOTURCO. THE MOTION WAS SECONDED BY J. O’RIORDEN AND APPROVED (5-0-1; K. MELANSON ABSTAINED).

4. Request for Determination of Applicability – 361 Cambridge Street – Barry N. Doherty – Clear trees/vegetation and extend lawn

Homeowner Barry N. Doherty represented this application.

Mr. Doherty explained the request to cut trees, construct a shed, and create a lawn and garden. He would also construct a rock wall along the back of the property.

E. Coleman commented that work had begun, when a resident noticed and notified the conservation office. She has no concerns with the proposed work.

October 25, 2018

Conservation Commission supported the construction of the rock wall in front of the approximate wetlands line. The applicant will not be taking down any more trees, but the conservation commission did note some dead trees that should be considered. Also, he will not fill in the yard, but would loam it.

No one spoke from the audience.

5. Public Hearing – Notice of Intent – 204 Fox Hill Road – Langone Development Group, Inc. – Demolish existing single-family dwelling and construct new single-family dwelling – DEP #122-617

Johnathan Langone of Langone Development Group, Inc. represented this application.

Mr. Langone worked with staff to develop a planting plan for this site, and agreed to pick up the debris.

Conservation Commission staff noted the pipe on the property is a town storm water pipe.

Conservation Commission requested that the grading on the site not create run off towards the neighbors and reminded the applicant to submit weekly inspection reports.

No one spoke from the audience.

J. Keeley reviewed the findings and conditions.

6. Continued Public Hearing – Notice of Intent – 34 Cambridge Street – TMC New England LLC – Construct various minor site modifications – DEP #122-615

Engineer Brian Dundan of RJ O'Connell & Associates, Inc. represented this application.

Mr. Dundan explained the changes since the last meeting:

- Slight modification to the exit lane of the drive thru, resulting in increased landscaping
- Topographical field work is complete, and the report is expected to be available Monday
- Discharge pipe from the building with the discolored water was inspected by Edens' plumber, and there are no issues, the theory is the iron content is coming from the broken pipe

Conservation Commission and staff had no comments.

No one in the audience spoke on this matter.

A MOTION TO REQUIRE A \$5,000 PERFORMANCE BOND FOR THE PROJECT AT 34 CAMBRIDGE STREET, DEP #122-615, WAS MADE BY I. DEB. THE MOTION WAS SECONDED BY W. BOIVIN AND APPROVED (5-0-1; K. MELANSON ABSTAINED).

7. Continued Public Hearing – Abbreviated Notice of Resource Area Delineation – Cambridge Street (Parcel 35-115-0) – Pondfield Solo 401(k) Trust – Resource area boundary confirmation – DEP #122-616

Wetlands Scientist Jonathan Shuster of Oxbow Associates represented this application.

Mr. Shuster noted that a portion of the channel is a stream, but most of it is not. The site is within the 100-foot buffer, which would be under the jurisdiction of the Conservation Commission. Also the value of the channel is lacking, and if this were a stream, would what feeds it be considered as stream as well?

J. Keeley conceded to identifying certain areas of the channel historic stream, such as points I/H to J and B to the unidentified point. He noted that both the Conservation Commission and applicant agree that point J to the wetlands is a stream. The Conservation Commission is not

determining the value of the stream, only if this channel is a stream.

It was the opinion of the Conservation Commission that the entire channel is a regulated stream under the local bylaw.

- E. Loturco – discussed the hydrology of point K
- I. Deb – explained the water enters the site from a point and ends at the wetlands
- W. Boivin – noted the precedent that when water is under a culvert it is not regulated and when it daylight it is regulated, and that a similar comparison could be made at the points of the stream when the water fans out
- L. Cohen – explained the history/intent behind the bylaw, and that the stream has a lot of value such as removing TSS.

No one in the audience spoke on this matter.

J. Keeley reviewed the findings and conditions.

L. Cohen requested adding language about the bank, and the applicant requested adding historical stream areas to the decision.

8. Continued Public Hearing – Erosion & Sedimentation Control Permit – 121 Lexington Street – 121 Lexington St. Realty Trust – Demolish existing 3-unit house and construct a new 3-unit residential building

No testimony was taken on this matter.
