

AMENDED ORDER OF TAKING

WHEREAS the Board of Selectmen of the Town of Burlington, County of Middlesex, being a board of officers upon whom authority to take real estate by eminent domain on behalf of the Town of Burlington has been conferred by law; and

WHEREAS by Order of Taking dated July 1, 1986, registered in the South Registry District of Middlesex County as Document No. 713394, noted on Certificate of Title No. 37609 and certain other Certificates of Title referred to therein, filed in said Registry District and recorded with Middlesex South District Deeds, Book 17159, Page 318, said Board, acting on behalf of the Town of Burlington, did take for said Town in fee for the purpose of preserving open space and the protection of the Town's Water and Resource District and Aquifer situated in said Town, a parcel of land consisting of a portion of the premises registered to Dominico B. Raimondo under said Certificate of Title No. 37609 and certain other lands, registered and unregistered, therein described; and

WHEREAS the said Board of Selectmen desires to amend and modify said Order of Taking hereinbefore referred to:

NOW THEREFORE, we the undersigned as we are all members of the Board of Selectmen of the Town of Burlington, in the County of Middlesex and Commonwealth of Massachusetts, acting for and on behalf of said Town, by virtue and in execution of the power conferred on us by Chapter 79 of the General Laws of the Commonwealth of Massachusetts and all acts amendatory thereof and supplementary thereto do hereby amend said Order of Taking made by this Board, dated July 1, 1986, registered in said Registry District and recorded with said Deeds aforesaid as follows:

By excepting and reserving to Boston Edison Company, a Massachusetts corporation and electric company, having its principal offices at 300 Boylston Street in Boston, Suffolk County, Massachusetts, any and all interests, rights and easements in said land taken, existing and for the benefit of said Boston Edison Company and in effect prior to July 1, 1986, as set forth in the following documents duly registered in said Registry District and/or recorded with said Deeds, namely:
