

◆ GETTING STARTED

Depending on the nature of your business, its location, and the amount of work you plan to do to the property, you will need to contact one or more of Burlington's departments and boards. The first place you should contact is the [Building Department](#). They will guide you through the following steps.

◆ ZONING

Burlington has several business zones, with different uses allowed in each. Local zoning requires all uses and exterior construction comply with a site plan approved by the Planning Board. To learn whether your proposed use and location conforms to zoning laws, contact the Building Department and/or the Planning Board. The [Zoning Bylaws](#) and [Maps](#) are on-line at www.burlington.org. Use variances are not allowed in Burlington. Some uses are only allowed by Special Permit issued by the Planning Board.

◆ BUILDING PERMITS

If you are doing ANY construction you will need a Building Permit. Check out the **Building/Development Process Handbook** at the [Building Department's webpage](#).

◆ SIGNS AND EXTERIOR CHANGES

All exterior signs and exterior changes to the building must be reviewed by the Building Department. The Sign Bylaws are part of the [General Bylaws](#). Article XIV and Zoning Bylaws Article VI and are available at the [Town Clerk's Office](#) or on-line at www.burlington.org

◆ PLANNING BOARD

The Planning Board is responsible for making decisions on site plans, site plan waivers, subdivisions, minor engineering changes, and special permits. For more information and applications, see the [Planning Board webpage](#).

◆ ZONING BOARD OF APPEALS

You must first obtain a letter of denial from the building inspector. [Zoning Board of Appeals applications](#) are available from the Town Clerk's office or on-line at www.burlington.org. Any Special Permit, Subdivision, or Variance that has been approved by the [Planning Board](#) or [Board of Appeals](#) is subject to a 20-day appeal period (after the decision has been filed with the Town Clerk). After the appeal period, **the applicant must have the decision certified by the Town Clerk then recorded at the [Registry of Deeds](#) in Cambridge and return the signed receipt to the Building Department with all required documents.**

◆ BOARD OF HEALTH

The [Board of Health](#) is responsible for a variety of permits and licenses governing food, hazardous materials, drainage, swimming pools, tanning, tobacco, pre-demolition/renovation, recreation camps, recombinant DNA, etc.

◆ ENGINEERING

The [Engineering Department](#) is responsible for issuing street openings, sewer and utility [permits](#).

◆ SELECTMEN

The [Board of Selectmen](#) have licensing authority in all other matters. [Applications](#) are available on-line at www.burlington.org from the Board of Selectmen.

The Zoning Bylaw and Zoning maps are on the web: www.burlington.org Fees are all paid to the cashier at the Treasurer/Collector's office. Contact the respective Department for their fee schedule.
- 2) Most retail uses do not require additional licenses or permits unless they offer food, tobacco, liquor, etc.
- 3) All exterior signs and exterior building changes must be reviewed by the Building Inspector.
- 4) The Town has a sewer allocation program. See the Town Engineer's webpage for further information.
